Call to Order Meeting

At 7:04pm Vickie Gill called the meeting to order.

Old Business

The previous meeting minutes were reviewed, a motion was made by Darrel Feaster and seconded by Greg, motion carried, and the minutes were approved.

New Business

Greg continues to meet with Brian updating the books and removing necessary items that we no longer own including outdated bunker gear.

Greg stated that we received a check from Traveler's Insurance for \$1127.00

Greg went to change trash companies several months ago and found out that we are in a contract with Waste Management until Spring of 2026. Once that contract expires, we will be changing companies.

Chipper has four members coming off probation-CJ Skalf, Shawn Little, Michael Titsorth and Chris Lacey.

Truck E232 needs a switch and has a water light on.

We have yet to receive a quote from Dave. Chipper is going to call Dave Ellis. We asked Jeff about a quote, and he told Chipper to get in touch with Dave. Jeff scheduled the job without approval.

Darrel said we have 3 vendors registered for the craft fair next month.

Darrel has also been checking with Tri-State Photo for dates and still hasn't gotten in touch with them.

Chipper requested adding a new member to the Fire Department, Zachery Duncan.

A motion was made by Vickie and seconded by Greg to add Zachery as a probationary member, the motion carried.

Chipper suggests that in the NERIS program we should enter the reports individually instead of all together like we did in NEFIRS.

Chipper talked about the ground settling and the concrete falling under two bays out front. Greg suggested we take measurements and keep track of how far it has fallen in.

Chipper suggested getting a special gift for Dave Martin to be given at the Christmas Dinner. Vickie makes a motion in approving up to \$800 for a golden axe plaque. Sommer seconds and the motion carries.

Chipper is also going to get a quote for T-shirts/Sweatshirts for the FD.

Vickie made a motion and Greg seconded that the meeting be adjourned at 8:08p.m. The motion was unanimously approved.
