Meeting of the Tyler Mountain Volunteer Fire Department Board of Directors
November 20, 2025

Call to Order Meeting

At 7:03pm Chris called the meeting to order.

Old Business

The previous meeting minutes were reviewed, a motion was made by Tim Ickes and seconded by Darrel, motion carried, and the minutes were approved.

New Business

Chris said that we received \$18,000 from the state quarterly payment.

Greg said that all vehicles that we no longer own are no longer listed on the balance sheet.

Greg spoke to our accountant on 11/20 to make sure that our 990 was finished by the end of the month. Form 990 must be on file with the county by 12/1 and with the state by 12/31/25.

Greg got a quote for the upstairs flooring in the fire department. Abraham Linc floor is the same flooring that is in Nikki's restaurant, it is a heavy weighted tile. The entire upstairs will be \$2,252.80. They are selling the flooring to us at cost.

Tri-State Floor Covering installation quote to prep the floor, apply a skim coat and install flooring will cost \$2750.00.

Vickie made a motion to approve the \$5000 to purchase and install the new floors, Chipper seconded, and the motion carried. Greg said that it will take 3 days to complete.

Chipper said that we need to get E231 and E232 fixed for we can get the pump tested. Unit 237 transmission cooler lines need replaced. He needs someone to take 237 to get a quote.

Chipper will call Atlantic to get a quote on 231 and 232. Then engines must be pump tested before January 1st.

Chipper got a price on an attic access door with steps for \$300-\$600. Greg made a motion, Darrel seconded and the motion carried to approve up to \$650 for the attic access door and stairs.

Chipper made a motion to accept Bryan Shackleford as a new member, Darrel seconded and the motion carried.

Chipper picked up the radios from the radio grant.

Darrel said we made \$602 on the craft fair. The photo drive is set for 11/30 and 12/7.

Chipper is going to apply for a few more grants that will help us pay for training classes.

Chipper spoke to the Fire Marshall's Office and said everything looks good in our fire reports.

Chipper made a motion to table Red Light Express calendar review until the January meeting. Vickie seconded and the motion carried.

Chipper told Darrel to set up CPR classes for the community. Darrel made a motion to charge \$50 per person to anyone signing up, Tim seconded the motion and the motion carried.

Greg made a motion and Chipper seconded that the meeting be adjourned at 8:23p.m. The motion was unanimously approved.
